Charge Application and Variations

Standard charges apply to:

- A person who, immediately before death or when reserving a plot, was resident in Blockley Parish
- A person who has been resident in Blockley Parish for not less than fifty years
- Burial in a previously purchased reserved plot or second burial in an existing plot
- Children of parents currently resident in Blockley Parish
- A person who, prior to death, was resident in hospital, home for the elderly, chronically ill or similar and, who immediately before removal to such place, was resident in Blockley Parish

Double charges apply to a person who does not fall within the Standard Charge categories but who in the past was resident, or whose parents or grandparents were at some time resident in Blockley Parish.

Quadruple charges apply to all other cases.

Notes:

A Plots may be reserved prior to death on payment to the Parish Council of the Plot Fee (Exclusive Rights to apply

for 75 years from the date of grant)

B Burials in Reserved Plots & second burials in the same plot require payment of the Burial Fee only

C Fees apply where first burial is to a depth not exceeding 2100mm (7ft). For each additional 300mm (1 Foot) or part thereof an additional £60 will be payable

Headstones, Monuments, Tablets & Inscriptions		Fee
1	A Flat stone not exceeding 2100 x 900mm	£100.00
2	A Headstone or Cross not exceeding 1200mm in height	£210.00
3	A Vase or similar not exceeding 300 x 300 x 450mm	£120.00
4	A Monument not exceeding 2100 x 900 x 450mm	£530.00
5	A flat Tablet not exceeding 450 x 450mm	£75.00
6	Additional inscription after the first or other works to the memorial	£75.00

Conditions

The following conditions apply before installation of a new memorial or any works to an existing memorial:

- Application form to be submitted to the Parish Council for approval
- Design and inscriptions to comply with Parish Council policy
- Construction and installation to comply with NAMM Code of Practice

The above Fees and Conditions to apply with effect from 1 January 2015.
