- 1. **Joe Harris has resigned** as leader of Cotswold District Council, with effect from May. He will continue to represent his ward in Cirencester and the Liberal Democrat group will undertake a selection process to choose his successor. https://news.cotswold.gov.uk/news/cotswold-district-council-leader-to-stand-down-after-six-years-in-role
- 2. There will be a **Homes and Interiors festival** on 29th March 2025. https://news.cotswold.gov.uk/news/cotswold-homes-and-interiors-festival-returns-to-cirencester
- 3. The **Low Income Family Tracker (LIFT)** is already showing some success with the first communications campaign identifying pension-age residents entitled to, but not claiming, Pension Credit. The campaign has delivered:
 - £68,545 in annual Pension Credit
 - £15,079 in backdated payments
 - £4,400 in Winter Fuel Payments

The lifetime benefit to this group of people is estimated to exceed £400,000 and further success has also been seen since the publication of this good news story:

- 4. The **Overview and Scrutiny** committee review the performance of the Council on a quarterly basis and I raised concerns about the Key Performance Indicator's (KPI) used to judge the performance of our waste collection service at the last meeting. New KPI's are being explored and it has been confirmed that repeated missed bins (3 reports from a resident) will automatically be escalated for investigation. While useful, this does not fulfil what is needed in my view and I will continue to pursue this matter, if additional KPI's (that accurately reflect the user experience) are not forthcoming.
- 5. The first meeting of the **Moreton Working Group**, designed to input in development issues for Moreton-in-Marsh, has been deferred again (due to the County Elections) and via Overview and Scrutiny I requested that the meeting be brought forward rather than delaying it, but to no avail. The provisional date circulated for the first meeting of the working group is 10th June 2025.
- 6. In the full council meeting of 19/03/25, we were presented with a motion relating to **Inheritance Tax reform and its impact on the farming community**. A second motion was promptly moved to refer the issue to the Overview and Scrutiny Committee and while I am pleased the impact on farmers in our area will be explored in detail through this route, it was disappointing to miss an opportunity to express our concerns and show our support for farmers, immediately. My views are as follows:

"Right now, many farming families in our District and beyond are facing uncertainty, fear, and frustration over the proposed changes.

Most people would agree that tax loopholes shouldn't allow the wealthiest to use farmland as a financial shelter, driving up land prices and locking out young and new farmers. But we must recognize the vital role that family farms play in producing our food, supporting our rural economy, and caring for

our natural environment. Any changes to inheritance tax must strike the right balance—preventing exploitation while protecting those who genuinely work the land.

Through food production and land management, we depend on the farming community to deliver a whole range of positive outcomes for our health and well-being, and for the environment. The introduction of the inheritance tax reform has undermined constructive conversations between the government and farmers on critical issues such as food production, job generation, climate change, and biodiversity protection. We need to invest in the future of farming, not undermine it and should strive for a tax system that is fair, transparent, and supports the long-term sustainability of British agriculture."

7. We also recognised **Unsung Heroes** at the full council meeting of 19th March 2025. I was pleased to nominate the Chipping Campden Repair Cafe volunteers for an unsung heroes award this month (see below) and delighted that Michael Smedley was able to collect the award in person at our full Council meeting this evening.

"I am nominating Michael for his sterling work at St James' Church Repair Cafe in Chipping Campden. Michael leads a very successful repair cafe which is a welcoming place to call in for a cuppa and connect with the community, saves countless items from heading to landfill by repairing or renewing them, saves the community of users money and extends the life of much loved items that residents do not wish to part with.

The social and environmental benefits of the cafe are significant and the services offered are highly valued by many local residents. Because the volunteers involved donate their time and skills, they offer residents an avenue for repair/renewing items that would often be financially prohibitive otherwise. This enables people to preserve and restore items of personal significance/emotional value and has a positive impact on the environment by reducing the need to buy new items (with an associated carbon footprint).

The repair process is often collaborative, so that users of the repair cafe can learn how to repair and maintain items themselves or understand how and where to obtain replacement parts.

All the volunteers involved in the cafe deserve to be recognised. There are a team (including children) who welcome attendees and serve them with tea and homemade cakes, repairers who diligently and patiently try all possible avenues to extend the life of items as well as those undertaking work behind the scenes to keep the cafe running. Michael publishes regular updates on the work of the cafe in local media and promotes the repair cafe through a number of different channels. Every town and village should have access to a repair cafe."

- 8. A second round of repatriation of staff from **Publica** to CDC has been agreed and will be completed in July. The services concerned are
 - Property and Estates
 - Waste and Recycling
 - Leisure Contract Management
 - Project management
 - Linkline/Careline
