

# **Blockley Volume/Speed Survey** February 2022

## Introduction

- This report provides a summary of the results of speed surveys that were carried out at four locations in the village of Blockley. The surveys took place between Thursday 10<sup>th</sup> and Wednesday 16<sup>th</sup> February 2022.
- The survey was carried out by means of an Automatic Traffic Counter (ATC) connected to pneumatic tube sensors attached to the surface of the carriageway. With a good road surface, careful installation and the level of traffic flow at this location, a high degree of accuracy is possible from the survey method employed. It is expected that the traffic flows are within +/- 2% and the speeds within +/- 3% overall.
- Speeds all speed surveys are carried out over a period of 7 days or more. The results given within this report are averaged over the 7-day period. The mean speed is the measurement used nationally in assessments for speed limits and is used within this report for consistency.
- Flows the figures given within this summary includes the combined two-way 24 hour flows, averaged for a day over the period of the survey. This reduces the effect of daily variations and gives the best indication of the overall traffic flows.








#### Site 186392 - Greenway Road

### Traffic volume

• On Park Road a range of 380 - 460 vehicles per weekday, along with Greenway Road and Station Road seeing a range of 1280 - 2220 per weekday were recorded during the surveys in Blockley. Generally, traffic volumes will be higher during the week than weekends, with Saturdays being busier than Sundays.

## **Speeds**

- The speed limit at all sites is 20 mph. Speed limits are based on Department for Transport (DfT) guidelines DfT Circular 01/2013 'Setting Local Speed Limits'. In simple terms, the DfT criteria states that the mean speeds should be comparable to the existing/proposed speed limit.
- The mean speed at sites 186390/2/3 are slightly over the posted speed limit ranging from 22-23 mph. Site 186391 falls within the appropriate range for the posted speed limit.
